# DISTRICT CONSERVATIONIST REPORT

February 23, 2024, through March 15, 2024

#### EQIP

- Planners are well into the planning phase for 1<sup>st</sup> batch applications. They are also working with 2<sup>nd</sup> batch applicants collecting eligibility documents.
- June 7<sup>th</sup> is when the contracts need to be completed by planners for 1<sup>st</sup> batch applicants.
- We are now collecting second-batch applications. Deadline: March 15<sup>th</sup>.
- We are accepting applications on a continuous process and batching accordingly.

EQIP/CIC

- These are 5-year contracts. Application batching follows the EQIP guidelines.
- Contract limits are \$200K per Farm Bill and are not part of the overall \$450K payment limit attached to the Farm Bill.

EQIP/IRA (Inflation Reduction Act)

• Funds are targeted towards Climate Smart Ag. Practices. The categories are Soil Health, Nitrogen Mgt., Livestock Partnership, Grazing & Pasture, Agroforestry, Forest and Upland Wildlife habitat, Energy, and Wetlands. The funding level for FY-24 is \$10.3M.

#### AMA/RMA

- Funding level is approximately \$80K.
- Normally used for small farm scenarios with a cap of \$50K per year.
- Batch dates are the same as EQIP.

#### CSP/IRA

- Like EQIP/IRA, it is for participants who sign up for the same targeted Climate Smart Ag through CSP. Practice categories.
- 5-year contracts up to \$200K.
- We are accepting applications for the 1st batch until March 22, 2024.

CSP

• We are accepting applications for FY-24 until March 22.

WRE

- Field offices are accepting applications for FY-24 until March 10.
- Field staff are directing participants to Elena Stewart (Program Manager) and Emily Palmer (Coordinator) for the specific details of the program.

#### **1.** Inspections and Site Visits

• Conservation Practice Installation and Completion Inspections: Korey continues working with landowners and contractors to complete project installation/inspections for prior-year contracts. David Stuckey (CD Tech.) is working with Korey to understand NRCS's survey, design, and inspection processes.

#### 2. Surveys/Designs

• Korey is working on surveys and designs for FY-24 projects with some assistance from Reed.

#### **3.** Other Business

- Planners continue reviewing prior year management practice records for payment and reporting progress.
- There are still positions being advertised for Delaware NRCS positions. District Conservationist (Dover/ New Castle F.O.), Outreach Coordinator (Dover S.O.).
- Sussex F.O. is still working to backfill for a Soil Con. Tech. Position.
- New hires: Sussex, James Pinkney, Soil Conservationist, replacing Kyle Hearn. Kent, Emily Gentry, Soil Conservationist. Dover S.O., Jennifer Richardson, Program manager for CSP and RCPP.

## SEDIMENT AND STORMWATER PROGRAM REPORT

#### **Detailed Plan Review/Approval:**

Staff continued to process plan submittals, pre-app/engineering meetings, and technical support. They reviewed 12 plans and approved six detailed plans and two standard plans. They also had 7 pre-application meetings.

Field staff continue to be busy. New projects continue to contact us for pre-construction meetings. Preconstruction meetings – 11

#### Maintenance Inspection – 47

Closed-out stormwater projects are inspected, and reports are generated that provide information on routine/preventive maintenance. The goal is to ensure the continued function of the stormwater facility.

Buddy Griffith provides compliance inspections on single-family lot construction. He also works with builders on the requirements under the Residential Standard Plan (silt fences and stone construction entrances). He and Faith work together on home construction complaints and reach out to non-compliant builders.

#### **Program Updates and News**

#### **District Operations**

• The Department's Bond Bill Hearing will occur in April this year; a date has yet to be selected. According to the Legislative Hall calendar, Bond Hearings will occur on **April 29**<sup>th</sup> and **30**<sup>th</sup>.

#### **Tax Ditch and Drainage Programs**

• Tax Ditch warrant change requests due to Michele Garner by **March 31**<sup>st</sup> to ensure all changes are brought before the respective District Board for approval in April for going into effect on 2024 Property Tax Bills.

#### Staffing Updates:

- <u>Posting Live! Planner IV Merit Position</u> This position will manage and oversee the administrative or technical services the Tax Ditch Program provides to Tax Ditch organizations and residents across the State.
- **Coming Soon KCD Contractual Planner II Position** Tax Ditch Officer Coordinator This position will be the primary point of contact for the Tax Ditch Officers across the State to help facilitate their needs and be responsible for officer recruitment and retention strategy implementation.

#### Sediment & Stormwater Program

The 2024 CCR certification course is live! Course modules and exam completion with a passing score of 80% or higher are due March 22<sup>nd</sup>. CCR course field trips will occur for all eligible students on March 28<sup>th</sup>.

#### Staffing Updates:

• The SSP would like to welcome William Lesmerises to the Program! He will start on March 25 as an Engineering/Planning Surveying Technician IV and primarily conduct sediment and stormwater inspections on construction sites in DE.

#### **Nonpoint Source**

- The FY24 Request for Proposals (RFP) closed on Friday, 3/1/24, for the Clean Water Act Section 319 grant funding. The NPS Program was advertising for up to \$324,000 in water quality BMP projects and received multiple proposals requesting approximately \$540,000. A grant review/ranking committee has been established and will meet on Monday, 3/18/24, to score all submitted proposals and select those that will receive awards. EPA Grant Project Officers will review those selected proposals before official approval.
- An environmental consultant is working on updating three existing watershed implementation plans for the NPS Program. These watersheds include the St. Jones River, Appoquinimink River, and Christina Basin (consists of the White Clay, Red Clay, Brandywine Creek, and Christina River sub-watersheds).

• A cover crop transect survey was completed throughout the State following the same protocols and survey route as the annual cropland residue transect. The study's data are being analyzed with assistance from the Chesapeake Bay Implementation Program.

#### **Staffing Updates:**

• No significant updates. All current Program positions are filled.

#### **Chesapeake Implementation Programs**

- The Chesapeake Bay Implementation Grant (CBIG) Request for Proposals period closed on March 1, 2024. Staff is reviewing and ranking project proposals. If a project is funded, the contact will be notified by the end of March or the beginning of April. Chesapeake Implementation Program staff may contact submitters for clarification or more details.
- Team members of the Chesapeake Implementation Program (ChIP) have assisted the NonPoint Source Program with mapping and data related to the Cover Crop and Tillage Transect Surveys.
- Staff from the Chesapeake Implementation Program attended the 2024 Delmarva Soil Summit from February 6th to 7th and staffed a booth providing information about DNREC's Chesapeake funding, CREP, and new incentive programs.
- Additional staff from the Chesapeake Implementation Program (ChIP) attended the Delaware Wetlands Conference from February 6th to 7th. During this time, they networked with different partners and agencies to expand programs and enhance mapping and analysis.
- The Chesapeake Implementation Program is currently setting up site visits for projects related to the Delaware Community Conservation Assistance Program (DeCAP). DeCAP is aimed at implementing conservation landscape best management practices for local landowners. Conservation landscape practices include – converting turfgrass areas to native meadow plantings, tree plantings, rain gardens, stormwater enhancements (bioswales, basins, and vegetated channels), constructed wetlands, and rainwater harvesting (rain barrels).
- The Chesapeake Implementation team is currently working on expanding the Forest Buffer Incentive Program to include grass buffers. This effort will help Delaware meet its Watershed Implementation Plan goals through 2025 and beyond.

#### Staffing Updates:

• No significant updates. All current Program positions are filled.

#### Spotlight

On February 6<sup>th</sup> and 7<sup>th</sup>, CPS staff attended the Delmarva Soil Summit in Salisbury, MD. The CPS had a booth where our available programs were promoted at the event, and staff were on hand to answer questions. The exhibit focused on DeCAP, the Buffer Incentive Program, and practices that homeowners can use to help improve local water quality. This event was partially funded by the CBIG, managed by ChIP of CPS, and put on by the Sussex Conservation District and partners.

# DACD REPORT

#### **UPDATES:**

• DACD-NRCS Agreement- NRCS and the districts met on 3/5 to discuss the expectations from the State Office and the NRCS Grants and Agreements Division (GAD) regarding the workload distribution between the districts and how to calculate costs for deliverables. As agreements and reporting receive ever greater scrutiny from GAD, these conversations help create a

shared understanding between the partners. Another A meeting is planned 3/29 to discuss deliverables and ensure consistency between NRCS and the districts regarding allowable activities and expenses.

- Delaware Envirothon Agreement—DACD is also working with NRCS on an agreement to support the Envirothon. NRCS and the districts recognize the Envirothon as a valuable outreach and education opportunity! Our draft agreement includes funding for part of the Envirothon coordinator, event, and travel expenses to the NCF Envirothon, representing \$21,419, or slightly less than half of the overall budget.

# AGRICULTURAL PROGRAMS REPORT

#### <u>Grants</u>

- Grant proposals for the Nonpoint Source Pollution (NPS) and Chesapeake Bay Implementation Grant (CBIG) were submitted on March 1, 2024. The DNREC Division of Watershed Stewardship's NPS Program already has \$75,000 set aside for SCD for cover crops, and the CBIG Program has \$364,540 set aside for SCD for cover crops in the Chesapeake Bay Most Effective Basin. SCD submitted two proposals for the following:
  - NPS \$125,000 for cover crops in the Inland Bays, Broadkill subwatershed of the Delaware Bay, and the Chesapeake Bay Watershed.
  - CBIG III \$250,000 for cover crops in the Chesapeake Bay Watershed.
- As part of the NRCS Contribution Agreement NR1921J2XXXXC005 SCD will host a Wetland Reserve
- Enhancement (WRE) workshop on March 19, 2024, at 5:00 p.m. at the Harrington Fire Hall. NRCS is organizing the program and will be lining up speakers. Please attend the workshop to learn more about the NRCS – WRE Program. As of the time of this report, 65 people have registered with hopes of getting 100 interested landowners from throughout the state to attend. If you are interested in attending, please <u>Register Here</u>.



- David and I attended the quarterly meeting with NRCS and the other districts to discuss the NRCS-DACD Agreement. Another meeting is scheduled for March 28, 2024, to review deliverables and determine what constitutes a deliverable. Discussions will also start soon to develop next year's FY 2025 work plans.
- SCD is also reviewing the FY 2025 Chesapeake Bay Regulatory and Accountability Grant (CBRAP) work plan, which funds compliance inspectors in the Ag and Stormwater Programs. The agreement's funding is \$150,000.

#### Cost-Share

- Cover Crop destruction forms were mailed out on March 6<sup>th</sup>. Destruction can begin on March 15, 2024, and we anticipate forms being submitted in the coming weeks.
- Oyster Aquaculture Program Update—Seven oyster farmers are currently enrolled in the program. Payments are made quarterly—October, January, April, and July. After the January payments (oysters harvested July-December), five of the seven oyster farmers submitted harvest reports, harvesting 149,771 oysters and receiving a total of \$7,488.55 in cost-share assistance. We anticipate receiving additional harvest reports in early April for oysters harvested from January through March.

#### 3921 Funds

• Letters will be mailed on March 21<sup>st</sup> reminding tax ditch officers that their FY 2023 and FY 2024 State and County Matching Funds (tax ditch cost-share) will be expiring July 1, 2024, and to submit any outstanding bills (mowing, bonding, and maintenance) for reimbursement. This year, there will be a new process to have all unused funds expire, requiring officers to reapply if they have not completed their planned maintenance projects. We also ask officers to notify us by June 14<sup>th</sup> if they are scheduling any tax ditch work over the summer months so we can hold those funds back.

#### **Miscellaneous**

 SCD will hold the 2024 Local Work Group Meeting on Tuesday, March 26, 2024, at 9 a.m. at the Vanderwende-Evans Conservation Center in Georgetown. A virtual option is also available for stakeholders who cannot join in person. Your input is essential to help determine the conservation needs of Sussex County and to shape the programs offered by the USDA-NRCS and the Sussex Conservation District. #### USDA Lease Updates & SCD Progress

In late February, we received a notice from USDA that the current "pre-solicitation" for office space issued on Nov. 22, 2023, was modified two times on Feb. 16 and Feb. 20 to reflect changes to parking requirements, electric vehicle charging stations, reduced the full term of the lease from 20 to 13 years. SCD was informed the Shortly Rd. location was not eligible due to its location within the 500-year flood plain. Letters of interest were due on March 7, 2024, and the results have yet to be shared. We understand that USDA and GSA are planning site visits within the next 30 days, and SCD is scheduled to participate in that activity.

Additionally, we are evaluating a proposal to engage GMB to assist with developing a plan that would allow us to locate the SCD Ag Program staff at Shortly Rd.

#### **Stormwater Conservation Stewardship Awards**

SCD recognized the winners of the 2024 Stormwater Conservation Stewardship Awards on Thursday, March 7, 2024. Approximately 75 recipients and guests attended.

#### **Cover Crops and Ag Census Data**

For the past few years, the three districts agreed to allocate the DDA cover crop money based on the acres of corn harvested in each county based on the most recent Ag Census Data (2017). The 2022 Ag Census Data was recently released, and the harvested corn acres shifted significantly between the counties, with Sussex Co. seeing a substantial reduction. Below is a comparison of the FY2024 DDA funding based on the 2017 and 2022 data. At this time, FY24 funding will be based on the 2017 Ag Census data, but this will prompt a discussion for FY25.

#### BACKGROUND:

This item was tabled from the February 2024 meeting as the board requested more information on the landowner's contribution to the project's design phase.

Should the Board want to require a landowner contribution during the design phase, staff recommends that It consider a 20% deposit option, as described on the following page.

With that said, my recommendation to the Board is to continue its policy of providing the landowner with the survey and design phase at no charge. This recommendation is based on the March 23, 2021, action by the Board to establish a pilot program utilizing \$50,000 of Conservation Cost Share funds for preliminary costs involved in developing a conservation project. The rationale behind this effort was to improve access to conservation programs while increasing the likelihood of implementation. Additionally, completing the design could improve access to other funding sources for implementation and provide the necessary matching funds when applicable. Additionally, SCD has utilized \$25,518.25 in funding on four projects, with another two in development (including O'Boyle), and I believe we should continue to see our initial commitment all the way through the process. Finally, as part of our mission, SCD has historically provided technical assistance to landowners at no cost, and I feel that this effort is no different.

#### **BACKGROUND ON O'BOYLE PROJECT**

SCD was contacted by Jordan O'Boyle, who owns a 9.5-acre parcel south of Mollyfield Rd. Dagsboro DE (Tax Map ID 233-10.00-71.04). Mr. O'Boyle is seeking SCD's assistance with designing and constructing an approximately  $1/3^{rd}$  acre wildlife/water quality enhancement pond on his property. An existing private ditch runs through the property, which would serve as an outlet for the pond. A water control structure would be installed to manipulate the water level based on significant rain events and time of year. This proposed project would create a habitat for various wildlife species, including fish, amphibians, reptiles, birds, macroinvertebrates, etc. For the pond to provide optimal wildlife habitat, it is proposed to include a wetland bench around the entire pond for beneficial aquatic plants. It would also have microtopography within the pond to provide different water depths. Excavated material will be used around the adjacent area to create minor topography and additional habitat. A final construction estimate will be developed once the design is complete, and a cost share request for implementation will be placed on a future agenda for the Board's consideration.

#### Estimated Pond Survey and Design Costs: \$6,625.00
